

ANNEXATION ORDINANCE NO. 96

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF WHEELER, WHEELER COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID TERRITORY WITHIN THE CITY LIMITS, AND GRANTING TO SAID TERRITORY AND ALL INHABITANTS OF SAID TERRITORY ALL OF THE RIGHTS AND PRIVILEGES OF CITIZENS OF SAID CITY AND BINDING SAID INHABITANTS AND FUTURE INHABITANTS BY ALL OF THE ACTS AND ORDINANCES OF THE CITY OF WHEELER

WHEREAS, all of the inhabitants and qualified voters of said hereinafter described territory have petitioned either in person or in writing, the City of Wheeler for the annexation of the hereinafter described territory to the City of Wheeler;

WHEREAS, said territory is contiguous and adjacent to the City limits of said and is not more than one-half ( $\frac{1}{2}$ ) mile in width;

WHEREAS, a majority of the inhabitants of said territory, who are qualified to vote for members of the State Legislature, have expressed their choice, and voted in favor of annexation of such territory to the City of Wheeler; in an affidavit signed by at least three of the inhabitants of said territory, qualified to vote for members of the State Legislature, they stated upon their oaths that all inhabitants residing in said territory, qualified to vote for members of the State Legislature, have had notice of the movement to annex said territory to the City, and that a majority of those residing in said territory and qualified to vote, have expressed their choice and have voted for annexation.

WHEREAS, said petition was filed with the City Clerk, on the 10th day of December, 1976, before the regular meeting of the City Council for the month of December.

WHEREAS, after hearing the arguments for and against said annexation, the City Council voted to grant such and to annex said territory to the City of Wheeler, Texas;

NOW THEREFORE, be it ordained by the City Council of the City of Wheeler, Texas;

That the following described territory, and all property therein be and the same is hereby annexed to the City of Wheeler, Wheeler County, Texas, and with the boundary limits of the City of Wheeler, Texas, be and the same are hereby extended to include all of said territory, within, the limits of said City and all said land and property therein, and the future inhabitants thereof shall hereafter be entitled to all of the rights, and privileges of other citizens of said City, and shall be bound by the acts and ordinance of the City of Wheeler, Texas.

The territory so annexed being described as follows:

BEGINNING at a point in the East line of the incorporated limits of the City of Wheeler, Texas, which point is 1190 feet East and 930 feet North of the Southwest corner of Section 5, A-4, of the H&GN Ry. Co. Survey, Wheeler County, Texas;

THENCE East parallel with the South boundary line of said Section 5, 1466 feet to a point in the East line of the West one-half of said Section 5, to a point for corner;

THENCE South with said line, 580 feet, to the present line of the incorporated limits of the City of Wheeler, Texas, to a point for corner;

THENCE West 1466 feet along the present incorporated limits of the City of Wheeler, Texas, to a point for corner;

THENCE North 580 feet along the present line of incorporated limits of the City of Wheeler, Texas, to the point of beginning and containing the strip of land 580 ft. X 1466 ft. which is the territory to be annexed to the City of Wheeler, Texas.

The City Clerk is hereby directed to file with the County Clerk of Wheeler County, Texas a certified copy of <sup>th</sup> this ordinance.

Passed by an affirmative vote of all members of the City Council, this 13 th. day of December, 1976.
